Also, it is recommended to obtain the necessary visa depending on individual situation.

- r) Effective from 15 October 2025, all travellers (including Macao SAR Passport holders) entering Sri Lanka for tourism or business purposes are required to obtain a valid Electronic Travel Authorization (ETA) prior to their arrival to Sri Lanka. Macao SAR passport holders can enter Sri Lanka visa-free for up to 30 days by selecting Chinese as their nationality when applying for the ETA. This visa-free entry only applies to those entering and leaving Uzbekistan by air, and upon arrival, they are required to present a return ticket or onward ticket to a third country within 10 days.
